

2010 1st & 2nd Quarter Reports

As of 6/30/10 reports



The General Fund's cash balance at the end of the 2nd Quarter, 2010 is \$123,842, whereas last year the ending cash balance was \$163,367. Total General Fund Revenue collections this quarter are \$1,976,356 and last year \$1,868,500. Total Revenues are at 47.8% of projections. The General Fund Total Expenditures are 45.72% of estimated \$4,051,456.

This report highlights changes in revenues and expenditures of the current period ending June 30, 2010 to the previous year 2009.

Salary & Benefits:

Public Works had some positions to fill for 2010 due to prior layoffs in 2009. Some positions were eliminated such as the Utility Service Worker I.

The Council funded 2 Laborer positions of which 1 was filled mid-year. There is currently a vacancy for Utility Service Worker II as well.

Park has 2 seasonal Full time employees which work from April or May to October.

Street and Water are slightly above the 50% target. Public Works salaries are charged to actual hours worked by fund.

Sewer is slightly down from the 50% target. Part is due to vacancies in positions that will be filled soon.

Public Works Funds for Park, Street, Water are at or below 50% target for the 2nd quarter ending June 30, 2010. The Sewer fund is showing slightly above at 53.4% as the annual debt payments for the 1990 PWTF and 1999 PWTF sewer improvements are paid in this period, as well as the Dept of Ecology SRF debt payment. These are an annual payment. Also, Operating Supplies are at 64%, but this can be attributed to a seasonal flucuation as well with purchase of safety related items and other.

RESERVES: The General Reserve (301) fund will see the Budget Amendment and transfer from Fund #225 CLID in the 3rd Quarter. This will be to close out the early call and payoff of the CLID bonds which occurred in April, 2010. Thus the fund will increase by \$272,000+.

Utility Reserve (302) - \$277,955 of \$303,224 Contribution to Sewer (402) Operating fund at 91.67%. This is needed for cash flow and will continued to be monitored closely. The City is still reviewing the water/sewer rate study and rates will need to be adjusted very soon to discontinue the use of Utility Reserve (302) for daily operations in Sewer (402).

Real & Personal Property tax collections are one of the largest revenue sources in the General Fund at \$590,245 estimated for 2010. It is estimated that the 2010 collections will be \$1,116,742 on 588,838,645 Assessed Value for a levy rate of \$1.8822 per 1,000. This was compared to 2009 which was \$1.9208 tax levy rate on 560,503,975 AV.

Sales Tax revenues are \$860,000 estimated for 2010 and \$426,570 or 49.6% has been collected to June 30, 2010. This amount is distributed to other funds such as 104/Street 20%; 301/General Reserve 10%; 304/Equipment Acqn Reserve; and 001/General Fund retains 69%.

Public Utility Taxes are taxed at 6% including Electric, Natural Gas, Telephone, Cellular and Pager taxes. These are estimated at \$691,008 with receipts of \$316,223 or 45.7%.

Brokered Natural Gas Tax: This was budgeted for 2010 as -0- due to a court decision that challenged if this was legally permissible or not, In July, the Supreme Court reversed the Court of Appeals decision in brokered natural gas use case. This decision keeps in place the longstanding interpretation for administration of brokered natural gas use taxes at the point of consumption for the approximately 50 cities that impose the tax. The 2008 Brokered Natural Gas revenue was \$37,648. The council will decide if they wish to amend the budget to include this revenue for 2010.

Development Fees are collected at the time of development within the City. This includes building permits, plan check, fire/life safety, all land use matters such as short plats, subdivision, rezones, conditional use, etc. This fund does NOT include other fees such as Impact Fees. \$24,443 has been collected to 6/3/2010 of the \$231,000 estimated or 10.6%. A large commercial permit is antipated in the 3rd quarter in excess of \$140,000 which will bring the estimated revenue back into the targeted amount for 2010.

Fines & Forfeits are running a little low at \$56,908 of \$149,000 estimated or 38.2%

Charges for Goods & Services are also tied to Fines & Forfeits (court collections) as well as Planning & Development Services. The court revenues are down as mentioned above. However, most of the Planning and Development fees are above projections:

2010 Quarterly Report (1st & 2nd Qtr) Subject:

Herein is the 1st and 2nd quarter (in other words, year-to-date) report for the Woodland Police Department. It is in the usual format.

In the first 6 months of 2010, WPD officers/staff drove 50,353 miles, handled 2533 incidents, wrote 577 police reports, issued 646 traffic tickets (of which 128 were criminal events like drunk driving, suspended drivers licenses, et al), gave 624 traffic warnings, and made 107 warrant arrests (ours and others).

73 felony crime arrests have been made, 216 misdemeanor arrests have been made, and 125 felony crimes and 201 misdemeanor crimes have been cleared.

Spillman RMS (our reporting system) shows our current incident clearance rate to be 68.73%.

As you look through the various attached reports, you will note that many of the numbers are different for like categories. Remember that each of these reports comes from a different source and the data is searched differently. For instance, Spillman reports only show numbers from actual entered/written police reports. WPD Month End Statistics come from the 911 CAD system and only show those incidents that received an incident (or case) number. The PD is looking good overall from a budget standpoint. If I read the new financial reports correctly, we are at 46.51% at the halfway point of the year. There are a couple of specific line items that aren't great (i.e. fuel consumed..a hard one to predict anyway due to fuel price fluctuations). On the other hand, so far, we're doing very well on jail costs (care and cust of prisoners, etc.) which is at only 31.58%. If this holds close to this throughout the year, it would be a good thing. Time will tell.





This report outlines our Fire Department activity from January through June 2010.

Introduction

This has been a very exciting year for the Woodland Fire Department. I started at the end of February as the new Chief and had the opportunity to lead our organization into a new 24-hour schedule with the addition of one more full time employee. That change to 24 hour staffing has been key to exceeding our response time goals and providing faster initial service to our citizens. This positive change has only been possible through the hard work, dedication, and flexibility of our entire membership. Volunteers along with Interns and Career Members have come together and worked through this challenging transition to not only maintain our high level of service, but improve it. I am grateful for all of their hard work and dedication.

Our dedicated members spend countless hours working to make sure that we provide the best response possible with the resources we have. The efforts put forth behind the scenes for: training, repairing and maintaining equipment and vehicles, skills practice, station maintenance, community service, public education, equipment testing, and other activities have kept our members very busy, but allow us to ensure a fast, reliable, and effective response when we are needed.

With over 560 responses in 2010 so far, we are on track to have one of busiest years ever for our Department.





Incidents by Time of Day




Incident Response Times

Number of Responses




Response Time by Hour of Day




