This form is used only to provide elevation information necessary to ensure compliance with applicable community floodplain management ordinances, to determine the proper insurance premium rate, and/or to support a request for a Letter of Map Amendment or Revision (LOMA or LOMR). **SECTION E CERTIFICATION**

Community officials who are authorized by local law or ordinance to provide floodplain management information, may also sign this certification. In the case of Zones AO and A (without a FEMA or community issued BFE), a building official, a property owner, or a owner's representative may also sign the certification.
