Lakeshore Drive sanitary and water improvement project: Ductile iron watermain installation and PVC Sanitary Sewer extension in Lakeshore Drive between Goerig Street and Island Aire Drive in Woodland, Washington. (Water main: 20 lf of 12" DI, 46 lf of 8" DI, 151 lf of 6" DI. Sanitary Sewer: 2289 lf of 12" PVC, 122 lf of 8" PVC, 210 lf of 6" PVC.)

Lakeshore Drive sanitary and water improvement project: located on Lakeshore Drive east of Goerig Street to Horseshoe Lake Park in Woodland, Washington. (Section 48 T5N R1W; Section 41 T5N R1E; City of Woodland, WA). The project site is entirely within City of Woodland right-of-way.

2% along the roadway. Fill side slopes of about 1H:1V to 1½H:1V

c. What general types of soils are found on the site (for example, clay, sand, gravel, peat, muck)? The Natural Resources Conservation Service (NRCS) map depicts four soil units within the project area: Newberg fine sandy loam, 0 to 3% slopes (141), Clato silt loam, 0 to 3% slopes (32), Pilchuck loamy fine sand, 0 to 8% slopes (160), and Fill land (Fn). The north portion of the project area is comprised of Clato silt loam, which transitions to Pilchuck loamy fine sand, and then to Newberg fine sandy loam within the southern portion of the project area. The southernmost portion of the project area in the vicinity of Horseshoe Lake consists of Fill land.

The Newberg series consists of very deep, somewhat excessively drained soils that formed in loamy and sandy alluvium from sedimentary and basic igneous rocks. Clato silt loam is very deep, well-drained soil formed in mixed alluvium, with moderate permeability, slow runoff, and high available water capacity. The Pilchuck series consists of very deep, excessively drained and somewhat excessively drained soils that formed in gravelly and sandy alluvium.

Newberg fine sandy loam, 0 to 3% slopes (141), Clato silt loam, 0 to 3% slopes (32), and Pilchuck loamy fine sand, 0 to 8% slopes (160) are considered prime farmland, but the project area is not within zoned agricultural land and is currently impervious surface and road shoulder.

d. Are there surface indications or history of unstable soils in the immediate vicinity? If so, describe.

e. Describe the purpose, type, total area, and approximate quantities and total affected area of any filling, excavation, and grading proposed. Indicate source of fill.

Approximately 3000 cubic yards of excavation estimated for the open trench sections of the watermain and sanitary sewer installations. The suitable excavated native material may be used for fill. The remainder of the fill will be imported by the Contractor.

- f. Could erosion occur as a result of clearing, construction, or use? If so, generally describe. Erosion from construction activities (trenching for utilities) could occur during construction if proper construction techniques are not utilized. Project specifications will provide for erosion control measures to be implemented during construction. Erosion Control measures will meet DOE requirements.
- g. About what percent of the site will be covered with impervious surfaces after project construction (for example, asphalt or buildings)?  
No additional impervious surface will be added as a result of this project. All work is within the existing paved area.
- h. Proposed measures to reduce or control erosion, or other impacts to the earth, if any:  
The Contractor will be required to incorporate provisions for erosion control such as use of wattles, silt fencing, catch basin filter sacks, visqueen, etc. during construction, as required by the contract.

Exhaust emissions from equipment, both diesel and gas operated, will take place during construction. Dust may be emitted during excavation activities and back filling of the utility trenches.

The contract will include provisions for dust control during construction. The contractor will minimize dust nuisance by cleaning, sweeping, sprinkling water, or other means. Internal combustion engines will not be allowed to idle for prolonged periods of time. The contractor will also be required to maintain construction vehicles and equipment in good repair.

The site is adjacent to Horseshoe Lake which is a shoreline of the state. The lake is fed by Lewis River water through an intake pump and the lake drains back into the Lewis River via an overflow structure.

Yes, the utilities will be placed within the existing street roadbed which is within the shoreline of Horseshoe Lake.

Stormwater is the most likely source of water run-off. Roadside curbing and catch basins will be used to collect on-site stormwater. The stormwater will be conveyed primarily by sheet flow and underground storm piping. Stormwater for the portion of roadway north of Park Road will be treated for water quality through approved stormwater treatment cartridge systems and then infiltrated on-site. All storm systems will be designed per the City of Woodland design and construction standards.

- 2) Could waste materials enter ground or surface waters? If so, generally describe.

According to the Utility Commission Maps, there are no underground hazardous liquid or gas transmission lines on the site. The Olympic Pipe Line Company has an underground line approximately 0.6 miles west of the site, and the Northwest Pipeline LLC has an underground facility approximately 0.9 miles east of the site.

Oil and fuel for construction equipment used during construction.

 Public streets that intersect the project include a fourway intersection of Goerig Street, Buckeye Street, Davidson Avenue, and Lakeshore Drive at the project’s north end; Park Street mid-project, and Island Aire Drive at it’s south end. Local and emergency access will be maintained for the duration of the project.

 The site is adjacent to a park and ride at the corner of Lakeshore and Goerig. The Lower Columbia CAP bus service connecting Vancouver and Longview, uses the park and ride twice a day for drop off and pick up.

 There is currently no parking on Lakeshore Drive and no parking spaces will be added.
