I. DESCRIPTION OF PROPOSAL

Applicant proposes to develop a new industrial site consisting of two 10,235 SF pre-engineered metal building (PEMB) warehouses. Proposed development includes a total of 24,916 SF of building area, including a 530 SF mezzanine in each building. Both buildings will serve as warehouses and distribution centers for two separate businesses, with potential for minor manufacturing work.

II. LOCATION OF PROPOSED DEVELOPMENT

The proposed development is located on lot # 508340101 off Howard Way in Woodland Washington. Subject property is currently a vacant lot with an approximate area of 1.64 acres, or 71,438 SF. A site visit has been performed, and best available resources considered, and no critical area(s) have been identified on the site. Subject property is located within the Centennial Industrial Park and is served by an existing stormwater system designed to accommodate the property.

III. ENVIRONMENTAL REVIEW

Per WMC 19.08.030, Site Plan Reviews shall be reviewed by the Development Review Committee. After the close of the comment period, the City will review any comments on the impacts of the project and decide whether to proceed with issuing a decision on the project.

The City of Woodland has reviewed the proposed project for probable adverse environmental impacts and expects to issue a determination of non-significance (DNS) for this project. The optional DNS process in WAC 197-11-355 is being used. This may be your only opportunity to comment on the environmental impacts of the proposed project. The proposal may include mitigation measures under applicable codes, and the project review process may incorporate or require mitigation measures regardless of whether an Environmental Impact Statement is prepared. A copy of the subsequent threshold determination for the proposal may be obtained upon request.

Agencies, tribes, and the public are encouraged to review and comment on the proposed project and its probable environmental impacts. Comments must be submitted by 5 p.m. on November 23rd, 2022 to:
