I. DESCRIPTION OF PROPOSAL

Applicant proposes to develop a new 11,500 SF light industrial building consisting of approximately 4,000 S.F. of general office space and 7,500 SF of warehouse and storage space. Primary use will be the assembly and maintenance of golf carts.

II. LOCATION OF PROPOSED DEVELOPMENT

The development is proposed at 1951 Schurman Way in Woodland Washington.

III. ENVIRONMENTAL REVIEW

A copy of the subsequent threshold determination for the proposal may be obtained upon request.

Agencies, tribes, and the public are encouraged to review and comment on the proposed project and its probable environmental impacts. Comments must be submitted by 5 p.m. on May 12th, 2022 to:
