The following project will be accomplished as a **SMALL WORKS PROJECT** and will be subject to prevailing wage laws.

Proposals for furnishing all materials, labor and equipment for the following described work will be received by the City of Woodland Public Works Office at 230 Davidson Avenue, Woodland, WA 98674 or by electronic mail at myklebustk@ci.woodland.wa.us, Bids will be accepted until 2:00 PM on Tuesday, March 29, 2022 .

PROJECT NAME: SMA-22-008 POLICE STATION PARKING LOT SEAL COATING

PROJECT DESCRIPTION: Project consists of cleaning, prepping, and seal coating approximately 36,507 sqft of asphalt, crack fill approximately 400 LF of ¼" or larger straight cracks (not alligatored areas), as well as re-stripe 46 parking stalls, 3 hashed areas, and repainting of 2 two color ADA stalls with hashed area. If you have concerns about locations or calculations, please contact us prior to submitting bid.

WORK MUST BE COMPLETE NO LATER THAN JUNE 10, 2022.

State Sales Taxes -- the provisions of Section 1-07.2(1) - Rule 171 – apply to this project. The Contractor shall include Washington State Retail Sales Taxes in the unit bid prices for the materials, equipment, and supplies purchased for this project.

Prevailing Wages are required on this project. The applicable wage rates are determined by the above bid due date and can be found electronically from the Washington State Department of Labor & Industries website. The contractor and each subcontractor shall complete a "Statement of Intent to Pay Prevailing Wages" and an "Affidavit of Wages Paid."

All construction and material, unless otherwise specified, shall be in accordance with the 2018 Standard Specifications and Standard Plans for Road, Bridge and Municipal Construction as prepared by the Washington State Department of Transportation and as amended under Amendments to the Standard Specifications, and the American Public Works Association, and the City of Woodland Engineering Standards for Construction.

The CITY OF WOODLAND reserves the right to cancel this request or reject any and all bids received or to waive any minor formalities of this call if in the judgment of the City Council the best interest of the City would be served.

Bidder agrees that the work will be completed by June 10, 2022; after Notice to Proceed is received from the City of Woodland. The City of Woodland is subject to inclement weather through the spring months. The Contractor should be aware of the potential for inclement weather and plan the project accordingly.
