PROJECT NAME: SOUTH PEKIN SEWER REPAIR PROJECT

PROJECT DESCRIPTION:

Installation of new sewer line and service connection on S Pekin in Woodland, WA. General project location is shown on included map. As-builts of original construction and video inspection report will also be provided. Project work shall include following work items and other necessary work for a complete project in accordance with City of Woodland standards and codes.

- 70 lineal feet 10-inch sewer line from Lift Station 9 on S. Pekin, south to 120 S. Pekin.
- Depth is approximately 10' to 15' deep.
- Reconnect 4-inch sewer service lateral to 110 S Pekin.
- Protect ALL Utilities on S Pekin. Locate/ Pothole to determine clearances. Provide concrete encasement as required.
- Trench Restoration, Pavement, Sidewalk, and Driveway Repair.
- Landscaping repair.
- Survey and shop drawing(s) to locate sewer line improvement, with profiles and sewer manhole invert elevations.
- Right-of-Way permit with approved Traffic Control Plan will be required.
- Coordination (48 hr notice) with City regarding residential access required.

The following City of Woodland Standards shall apply:

- General Requirements including traffic control, utility location notifications, testing and acceptance (S-01)
- Sewer pipe shall be PVC conforming to ASTM D3034 SDR 35 with minimum pipe stiffness of 46 psi. All sewer pipes shall have an integral bell gasket joint with elastomeric gasket and shall be furnished in 12 1/2 laying lengths. (S-01)
- Sanitary sewer pipe bedding (S-02)
- Trench restoration, backfill, bedding and hot mix Asphalt Concrete surfacing (S-03)
- Service lateral connections and stub outs (S-04)
- Concrete encased sewer pipe for water line crossing (S-06)
- Driveway with Attached sidewalk (T-05)

State Sales Taxes -- the provisions of Section 1-07.2(2) - Rule 170 – apply to this project. The Contractor shall include Washington State Retail Sales Taxes on the full contract price.

All construction and material, unless otherwise specified, shall be in accordance with the 2018 Standard Specifications and Standard Plans for Road, Bridge and Municipal Construction as prepared by the Washington State Department of Transportation and as amended under Amendments to the Standard Specifications, and the American Public Works Association, and the City of Woodland Engineering Standards for Construction.

The CITY OF WOODLAND reserves the right to cancel this request or reject any and all bids received or to waive any minor formalities of this call if in the judgment of the City Council the best interest of the City would be served.
