PROJECT DESCRIPTION: Project consists of Prep (saw cut and place gravel and placing approximately 21-tons of asphalt at 15 locations within the city); Place (place and compact 3" of ½" PG 64-22 HMA, as well as sand and tack the edges); and Traffic Control (for Prep & Place or just Place) as specified line items. The city will provide required permits. Bid Proposal is broken down in 3 ways: 1) Contractor Preps, Places Asphalt, all Traffic Control. 2) City Preps, Contractor Places Asphalt & Provide Traffic Control for their work. 3) City Preps and Provides all Traffic Control, Contractor Places Asphalt.
