The following project will be accomplished as a **SMALL WORKS PROJECT** and will be subject to state and federal prevailing wage laws.

Proposals for furnishing all materials, labor and equipment for the following described work will be received by the City of Woodland Public Works Office, electronic mail at myklbustk@ci.woodland.wa.us or by hand at 236-B Davidson Ave, Woodland, WA 98674 on Wednesday, October 12, 2022, at 5:00 PM. If forwarded by U.S. mail, the sealed envelope containing the proposal shall be enclosed in another envelope addressed to the City of Woodland, PO Box 9, Woodland, Washington 98674.

PROJECT NAME: SIDEWALK & CATCH BASIN REPAIR PROJECT

PROJECT DESCRIPTION: This project consists of removal and replacement of curb, gutter, sidewalk, catch basin, and storm piping repairs, as needed, at multiple locations as shown in Exhibit A and site visit. Right-of-Way Permit is required with applicable traffic control plans submitted. Mandatory site visit required to bid, as field engineering will be required, utilizing City of Woodland Standards and Specs. Scheduled times are Wednesday, September 28, 2022, at 2:00 pm or Thursday, September 29, 2022, at 8:00 am. Please contact Public Works at 360 225-7999 to schedule and/or if you are unable to make either of those times.

Inquiries regarding the project should be directed to Public Works at myklebustk@ci.woodland.wa.us or 360 225-7999. All proposals must be submitted on the regular furnished form. Work shall be completed no later than December 2, 2022, with fines of \$100/day for exceeding this limit.

State Sales Taxes -- the provisions of Section 1-07.2(1) - Rule 171 – apply to this project. The Contractor shall include Washington State Retail Sales Taxes in the unit bid prices for the materials, equipment, and supplies purchased for this project.

All construction and material, unless otherwise specified, shall be in accordance with the 2018 Standard Specifications and Standard Plans for Road, Bridge and Municipal Construction as prepared by the Washington State Department of Transportation and as amended under Amendments to the Standard Specifications, and the American Public Works Association, and the City of Woodland Engineering Standards for Construction.

The CITY OF WOODLAND reserves the right to cancel this request or reject any and all bids received or to waive any minor formalities of this call if in the judgment of the City Council the best interest of the City would be served.

The undersigned, as bidder, declares that we will contract with the City of Woodland to do everything necessary to complete the City of Woodland Sidewalk & Catch Basin Repair Project (SMA-22-010) as presented. Bid Bond is not required.

We understand that the City of Woodland reserves the right to reject any or all bids and to determine which proposal is, in the judgment of the City of Woodland, the lowest responsible bid, and which proposal, if any, should be accepted in the best interests of the City of Woodland and that the City of Woodland also reserves the right to waive any informalities in any proposal or bid.

We further state that we have not, either directly or indirectly, entered into any agreement, participated in any collusion, or otherwise taken any action in restraint of free competitive bidding regarding such contract.

Bidder agrees that the work will be completed by December 2, 2022, with fines of \$100/day for exceeding this limit. The City of Woodland is subject to inclement weather through the fall and winter months. The Contractor should be aware of the potential for inclement weather and plan the project accordingly.
