The following project will be accomplished as a **LIMITED SMALL WORKS PROJECT** and will be subject to prevailing wage laws.

Proposals for furnishing all materials, labor and equipment for the following described work will be received by the City of Woodland Public Works Office at 236-B Davidson Avenue, Woodland, WA 98674 or by electronic mail at [myklebustk@ci.woodland.wa.us](mailto:myklebustk@ci.woodland.wa.us). Bids will be accepted until 4:00 PM on Thursday, September 7, 2023.

**PROJECT NAME:** SMA-23-010 2023 ASPHALT REPAIR PROJECT

**PROJECT DESCRIPTION:** Project consists of prepping- saw cut, remove fill, prepare gravel base; and placing approximately 9 tons of asphalt at various locations within the city. 4 locations have already been cut, as shown on the attached list. The contractor will place and compact 3" of ½" PG 64-22 HMA, as well as sand and tack the edges. Traffic Control listed as line item. The city will provide required permits. A map of site locations is included, as well as a chart of area calculations. A MISC line item was included to allow for additional locations to be added as needed. If work location is adjusted, unit pricing to remain the same. If you have concerns about locations or calculations, please contact us prior to submitting bid.

All proposals must be submitted on the Bid Proposal Form that is being furnished. Work shall be completed within twenty (20) working days after receipt of permission to proceed.

State Sales Taxes -- the provisions of Section 1-07.2(1) - Rule 171 – apply to this project. The Contractor shall include Washington State Retail Sales Taxes in the unit bid prices for the materials, equipment, and supplies purchased for this project.

Prevailing Wages are required on this project. The applicable wage rates are determined by the above bid due date and can be found electronically from the Washington State Department of Labor & Industries website. The contractor and each subcontractor shall complete a "Statement of Intent to Pay Prevailing Wages" and an "Affidavit of Wages Paid."

All construction and material, unless otherwise specified, shall be in accordance with the 2018 Standard Specifications and Standard Plans for Road, Bridge and Municipal Construction as prepared by the Washington State Department of Transportation and as amended under Amendments to the Standard Specifications, and the American Public Works Association, and the City of Woodland Engineering Standards for Construction.

The CITY OF WOODLAND reserves the right to cancel this request or reject any and all bids received or to waive any minor formalities of this call if in the judgment of the City Council the best interest of the City would be served.

We further state that we have not, either directly or indirectly, entered into any agreement, participated in any collusion, or otherwise taken any action in restraint of free competitive bidding regarding such contract.

Bidder agrees that the work will be completed within twenty (20) working days after Notice to Proceed is received from the City of Woodland. The City of Woodland is subject to inclement weather through the fall and winter months. The Contractor should be aware of the potential for inclement weather and plan the project accordingly.

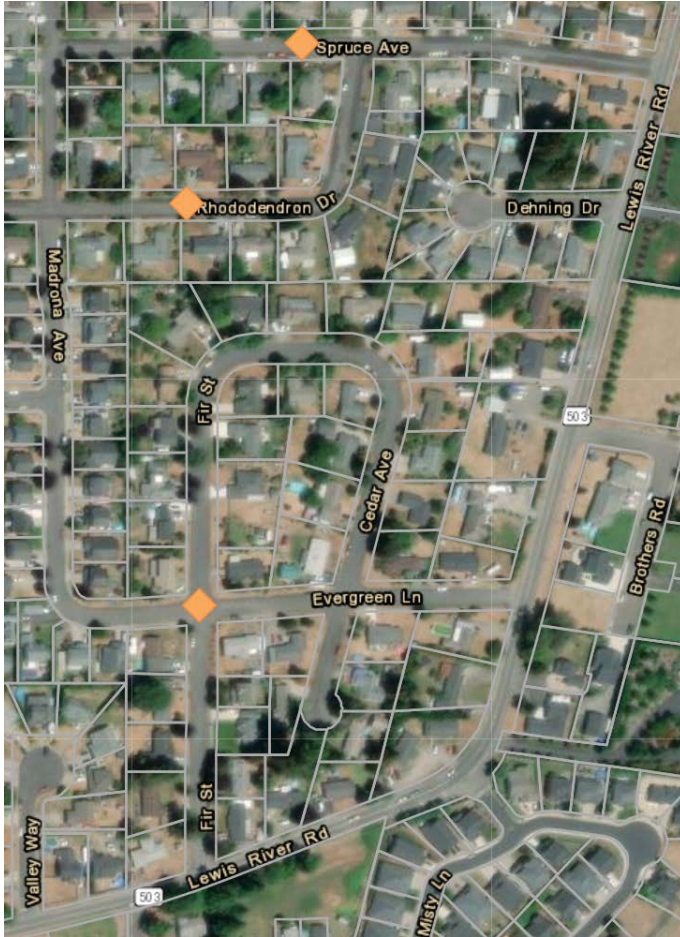
